# RECORD OF THE PROCEEDINGS SKAGIT TRANSIT BOARD OF DIRECTORS

Wednesday, April 15, 2015

The Skagit Transit Board of Directors met in regular session in Mount Vernon on Wednesday, April 15, 2015. Mayor Jill Boudreau called the meeting to order at 1:00 p.m. followed by the Pledge of Allegiance, Roll Call, and Introductions.

- II Consent / Action Items:
  - a) Approval of Minutes

Ms. Gere moved to approve all Consent / Action items. Mr. Wesen seconded the motion. The motion passed unanimously.

## III Full Discussion/Action Items:

#### a) Monthly Budget Update

Mr. O'Brien reported Skagit Transit received \$688,979 sales tax revenue in the month of March. This compares with \$667,641 in March of 2014. This is a 3.2% or \$21,338 increase over last year with a year to date increase of 5.0% or \$113,440.

Mr. O'Brien stated expenses included MOA Feasibility Study, Revenue Vehicles parts and supplies, and software annual maintenance renewal. Fuel is within budget and all other expenses were as expected.

Ms. Gere moved to approve the Monthly Budget Update. Mr. Rick DeGloria seconded the motion. The motion passed unanimously.

#### b) Fare Free Day for Project Homeless Connect

Mr. O'Brien stated Project Homeless Connect is a one-day event that aims to engage the local community and build sustainable partnerships to help end homelessness. Free services will be provided by local non-profits, businesses, and volunteers. The event will take place on Friday, September 11, 2015 at Skagit Valley College. Event organizers have requested Skagit Transit continue support of the event by operating fare free on September 11<sup>th</sup>. Mr. O'Brien reminded the

Board in the past the day has been advertised as Try Transit day where new riders can explore transit fare free.

Ms. Janicki moved to approve Fare Free Day for Project Homeless Connect. Mr. Anderson seconded the motion. The motion passed unanimously.

Chair Boudreau announced that the Board would adjourn for an Executive Session to review the union contract. Ms. Boudreau stated that the estimated time for the session is 20 minutes.

Mr. O'Brien stated staff made a decision not to provide public restrooms at Park & Rides for a multitude of reasons. Mr. O'Brien noted recently Port-a-Potties were reinstalled at March Point Park & Ride and staff will look at providing Port-a-Potties at Chuckanut Park & Ride. Ms. Boudreau requested staff bring details of progress on adding the Port-a-Potties to Chuckanut Park & Ride to the May meeting.
