## III. Notes from the field:

There was discussion about the notice at March's Point regarding the temporary closure of the outdoor toilet there. The wording of the notice was odd and passengers were amused by it. Dale O'Brien expressed the ongoing challenge of bathroom vandalism.

#### IV. General Update:

Alger Park and Ride opened March 3rd. It will be closed March 17 and 18 for construction modifications to the entrance and exit.

The group discussed developments with the Transportation Day event at the Cascade Mall scheduled for July 19<sup>th</sup>. A ST bus will be parked inside the mall one week in advance of the event, July 11<sup>th</sup>. The parked bus will be the wrapped bus with children on it. A bus outside the mall will be giving trips to passengers. Volunteers from ST will be needed to drive the outdoor bus, staff an indoor table, and to staff the indoor bus. The committee working on the event plans to give out free tickets for a goodie-basket raffle. Three baskets are being discussed. Goodies are to be donated by the Mall, ST, and Community Action. There will be a coloring table for small children and possibly an art contest for older kids. The group passed around an example of the artwork that came out of such a competition in the Salem area.

Susan Pole discussed the idea of broadening community perceptions of who rides transit and about branding Skagit Transit in a way that encourages a broader cross section of the community to ride. Joy
