# RECORD OF THE PROCEEDINGS SKAGIT TRANSIT BOARD OF DIRECTORS

Wednesday, August 16, 2017

The Skagit Transit Board of Directors met in regular session in Burlington, WA. Chair Wagoner called the meeting to order at 1:01 p.m. followed by the Pledge of Allegiance, Roll Call, and Introductions.

Ms. Boudreau moved to approve all Consent / Action items. Mr. Sexton seconded the motion. The motion passed unanimously.

## III Full Discussion/Action Items:

#### a) Monthly Budget Update

Ms. Pleasant stated Skagit Transit received \$997,871 in sales tax revenue in the month of July. This compares with \$878,590 in July of 2016. Ms. Pleasant noted this is a 13.6% or \$119,281 increase over last year with a year to date increase of 8.6% or \$510,824. Skagit Transit also received \$171,647 in federal and state grant reimbursements.

Ms. Pleasant reported capital expenses included Vanpool replacement van, March's Point Park & Ride security camera wiring upgrades, and Skagit Station EV Station Project. Ms. Pleasant noted fuel is within budget.

Ms. Boudreau moved to approve the Monthly Budget Update. Mr. Quam seconded the motion. The motion passed unanimously.

## b) Public Hearing for Six Year Transit Development Plan Public Comment

Mr. Wagoner opened the Public Hearing for the Six Year Transit Development Plan at 1:05 p.m. and asked for public comment. Mr. Wagoner noted two written public comments were received included in the final Transit Development Plan. No other comments were received. Mr. Wagoner closed the public comment period at 1:06 p.m.

### c) Resolution 2017-06 Approve 2017 – 2022 Transit Development Plan

Mr. Windler informed the Board no later than September 1st each year, transit agencies in the State of Washington are required to submit a Six Year Transit Development Plan (TDP) to the Washington State Department of Transportation.

Skagit Transit released a draft TDP for a thirty-day public comment period on July 17, 2017. Mr. Windler noted two public comments were received and included in the final TDP.

Mr. Windler reported TDP identifies planned activities for the period 2017 to 2022. Annual updates reflect changing funding realities, policy goals, and new opportunities. Projects must be listed in the TDP to be eligible for state and federal grants.

Mr. Wesen inquired about the upgrade to electric and double tall coach mentioned in the public comments received from Valarie Rose. Mr. Windler stated double tall coaches and articulated coaches are being considered for high volume commuter routes. The 80X county connector from Bellingham provides WWU students a ride from Bellingham to Everett Station. Future needs could require a high capacity bus, which are currently being used in our region by Community Transit and Metro. Mr. Windler noted the Community Advisory Committee reviewed the TDP and the committee prefers the double tall option.

Ms. Boudreau moved to approve Resolution 2017-06 Adopting the Six Year Transit Development Plan. Mr. Wesen seconded the motion. The motion passed unanimously.

### d) 2017 Federal Section 5307 and 5339 Grant Award

Mr. O'Brien stated on September 15, 2010, the Board passed Resolution 2010-09 authorizing the Executive Director to sign grant agreements upon Board approval of the project and funding of the grant award. The following is for Board approval for the award of 2017 Federal Section 5307 and 5339 to Skaqit Transit.

- Federal Fiscal Year 2017 Federal Transit Administration Section 5339 funds apportioned to Skagit Transit from Puget Sound Regional Council - \$34,938. Staff will program these funds to the Architect and Engineering services project for the MOA II. Staff will use a portion of the value of the property at 11784 Bay Ridge Drive as in-kind match.
- 2. Federal Fiscal Year 2017 Federal Transit Administration Section 5307 funds apportioned to Skagit Transit from Puget Sound Regional Council \$305,572. The funds are available to assist capital and operating projects, FTA places a cap on the amount available for operating assistance.

Mr. O'Brien noted Skagit Transit will program the maximum amount available for operating assistance to support the Everett Connector service in the amount of \$122,213. Federal funding shown is 50% of the project costs.

Mr. O'Brien stated the balance of \$183,359 will be programed to the Architect and Engineering services project for the MOA II. Skagit Transit will use a portion of the value of the property at 11784 Bay Ridge Drive as in-kind match.

Ms. Boudreau moved to approve the 2017 Federal Section 5307 and 5339 Grant Award. Ms. Gere seconded the motion. The motion passed unanimously.

## e) Award Landscape Maintenance Contract #17-011-P

Mr. O'Brien reported the existing Landscape Maintenance Services Contract #12-001 with Garner's Northwest, Inc. expires August 31, 2017. All Option Year terms have been exhausted and it is necessary to rebid the contract. Management determined the scope of the new contract would include only scheduled service to Skagit Station and the Chuckanut Park & Ride. Mr. O'Brien noted historically, all of the Agency's facilities were serviced under this contract but the majority of the work can now be performed by the Facilities staff, which has grown in the last five years.

Invitation For Bids (IFB) #17-011-P were issued and posted on Skagit Transit's website on August 2, 2017. Bid notices were posted at Skagit Station, the MOA, on Skagit Transit's website, and sent to ten potential vendors on the Vendor Bid List. Mr. O'Brien stated the legal advertisement was published in the Skagit Valley Herald on August 3, 2017. No Addenda were issued. Mr. O'Brien informed the Board only a single responsive bid was received by Garner's Northwest, Inc. and was opened at 2:00 pm on August 14, 2017 in open public meeting in the MOA Administrative offices. A Price Analysis determined that the prices offered are fair and reasonable, within budget, and that the total Contract Amount based on Garner's pricing over a five-year term is within the Agency's Independent Cost Estimate.

Mr. Wesen asked why scheduled service would be provided at two facilities, Skagit Station and Chuckanut Park & Ride and not for other Park & Ride facilities. Mr. O'Brien stated due to foliage and weeding landscape service is required on a regular basis at these locations. Mr. O'Brien noted staff will maintain the rest of the facilities.

Ms. Boudreau moved to Award the Landscape Maintenance Contract #17-011 to Garner's Northwest, Inc. Mr. Sexton seconded the motion. The motion passed unanimously.

#### IV Information Items:

Mr. Wesen asked for an update on the property purchase. Mr. O'Brien stated attorneys are preparing pleadings. Staff expects to review the pleadings next week. Once the review is complete, the Seattle law firm will file the pleadings.

## **INFORMATION:**

The monthly budget reports are presented for your review. Items of interest are:

### Revenues:

Skagit Transit received \$1,060,841 sales tax revenue in the month of August. This compares with \$1,004,048 in August of 2016. This is a 5.66% or \$56,793 increase over last year with a year to date increase of 8.13 % or \$567,617. Skagit Transit also received \$50,909 State and Federal grant reimbursement.

**SUBJECT: 2017-2019 Washington State DOT Vanpool Investment Program Funds** 

## **INFORMATION:**

On September 15, 2010, the Board passed Resolution 2010-09 authorizing the Executive Director to sign grant agreements upon Board approval of the project and funding of the grant award. The following is presented for Board approval for the award of 2017-2019 Washington State DOT Vanpool Investment Program (VIP) funds to Skagit Transit.

Washington State DOT VIP funds in the amount of \$191,750, for the purchase of up to 10 replacement vanpool vehicles. Grant funds assisting in this project cannot exceed \$19,175 per vehicle. The grant requires a minimum of 35% match to the total project cost.

### **RECOMMENDATION:**

Staff recommends the Board approve the grant project and budget, and authorize the Executive Director to execute the grant agreement.

## **BUDGET IMPACT:**

Local match required is 35% of the total project cost (\$295,000 estimation). The minimum impact to the budget; \$103,250.

SUBJECT: Approve Interlocal Agreement between Skagit Transit and

City of Mount Vernon (Skagit Transit No. 17-014)

## **INFORMATION:**

Skagit Transit's current strategy is to replace its high cost fiber connections for its Wide Area Network (WAN) with lower cost alternatives, strategically re-map its WAN, and establish multiple connections to various facilities. On June 21, 2017, the Board approved an Interlocal Agreement between Skagit Transit and the City of Burlington for dark fiber connectivity between the MOA, Chuckanut Park and Ride, MOA-2 at the Port of Skagit, and Skagit Station.

The City of Mount Vernon's Fiber System can provide a dark fiber connection to replace the existing, and more expensive, Wave fiber at the South Mount Vernon Park and Ride (SMVP&R), and further integrate SMVP&R, Skagit Station, and the rented office space on 310 Pine St. to Burlington via the City of Mount Vernon's rights of way to terminate into the City of Burlington's colocation site. Fiber at the SMVP&R is currently \$280 per month, excluding tax.

Pursuant to the authority granted by Chapter 39.34 RCW, Interlocal Cooperation Act, Skagit Transit desires to enter into an Interlocal Cooperative Agreement with the City of Mount Vernon for the provision of the above mentioned connections. Skagit Transit will pay a monthly rental fee per connection. Additional fees will apply for installation, splicing, termination of equipment, certification or permits for bringing fiber into the SMVP&R.

## **RECOMMENDATION:**

Authorize the Executive Director to execute an Interlocal Agreement with the City of Mount Vernon for dark fiber connectivity to the City's Fiber System.
