Louise Eden wanted to say good job to the paratransit drivers who serve the Life Care Center. They are great drivers who provide wonderful customer service. Lynne Jordan wanted to pass along that some drivers may not be aware of those citizens who may be banned from riding. Doris Brevoort said that the bus stop and Division and 6th frequently has a car parked in front of that stop and thought this might be an issue for drivers.

Joe Kunzler discussed paratransit and that there are not fares charged currently. He had reservations about charging a fare when there are forms of revenue like advertising and marketing revenue that we are not collecting. Joy Kane mentioned that Medicaid Transportation is pushing clients onto PT and should Skagit Transit look out for them. Is there a way to put some thought into protecting those who could not afford a fare? Valerie Rose said that it sounds like means testing and it makes a lot of sense. Joy said who could we work with to assist with paying for paratransit?
