Ridership Update Skagit Transit Cheryl Willis:

Both Fixed Route and Paratransit services incurred ridership increases in August over the year prior. Fixed route 3.3% increase Paratransit 4.21% increase.

The performance metric of 200 rides per week on Guemes Island was established for the continuation of the pilot shuttle service. Ridership was below target in both June, July, August and September. As a result of low ridership, the pilot is discontinued October 1st.
