Wednesday, October 18, 2017

The Skagit Transit Board of Directors met in regular session in Burlington, WA. Chair Wagoner called the meeting to order at 1:01 p.m. followed by the Pledge of Allegiance, Roll Call, and Introductions.

Ms. Gere moved to approve all Consent / Action items. Mr. Wesen seconded the motion. The motion passed unanimously.

#### III Full Discussion/Action Items:

#### a) Monthly Budget Update

Mr. O'Brien stated Skagit Transit received \$1,043,704 in sales tax revenue in the month of September. This compares with \$990,139 in September of 2016. Mr. O'Brien noted this is a 5.41% or \$53,565 increase over last year with a year to date increase of 7.79% or \$621,182.

Mr. O'Brien reported expenses included Skagit Station Lobby benches, farecard machines, hot water pressure washer, and Apollo Video Software License. Mr. O'Brien noted fuel is within budget.

Mr. Wagoner congratulated Motoko Pleasant and informed the Board members he attended the Washington State Auditor's exit interview. Mr. Wagoner noted the auditors gave Skagit Transit a clean audit. The auditors were impressed with Motoko and staff.

Mr. DeGloria moved to approve the Monthly Budget Update. Ms. Janicki seconded the motion. The motion passed unanimously.

## b) Award A/E Services Agreement #17-013-F for MOA-2 Design

Mr. O'Brien stated on February 17, 2016, the Board approved and authorized the Executive Director to sign a grant agreement for the development and administration of designing MOA-2 at the Port of

Skagit. Skagit Transit does not have sufficient or experienced staff to meet the required commitment for the design of this facility therefore it is advisable and desirable to obtain the necessary Architectural and Engineering (A/E) services for this project from a professional A/E Consultant.

Mr. O'Brien noted Pursuant to 40 USC 1102 (The Brooks Act) and RCW 39.80 governing contracts and procedural requirements for the procurement of A/E services, Skagit Transit published Request For Qualifications (RFQ) #17-013-F on August 31, 2017 by posting the documents on its website. This process results in the most highly qualified consultant with price being negotiated after contract award. Mr. O'Brien stated if a fair and reasonable price cannot be negotiated with the top ranked firm, negotiations with that firm will terminate and Skagit Transit will enter negotiations with the second highest-ranking firm.

Mr. O'Brien informed the Board the legal ad for the RFQ was published twice in the Skagit Valley Herald. Notices were posted at Skagit Station, the existing MOA facility, and sent to 90 A/E firms on the MRSC Consultant Roster specializing in A/E Services for Transit Planning and Design. Nineteen firms were represented at the Pre-Submittal Meeting held at Skagit Station on September 7, 2017.

Mr. O'Brien stated three responsive submittals were received by the September 21st deadline. Presentations and interviews were conducted with all three candidates on October 3rd, immediately followed by evaluations by a three member Selection Committee: Dale O'Brien, E.D. for Skagit Transit; Pete Stark, GM for the Whatcom Transportation Authority (WTA); and Brad Windler, Service Development Planner for Skagit Transit.

Mr. O'Brien stated pending successful negotiations, Skagit Transit recommends that the Architectural and Engineering Services Agreement #17-013-F be awarded to TCF Architecture. In the event an agreement cannot be reached, Skagit Transit further recommends the Contract be awarded to Tetra Tech, Inc.

Mr. Wagoner inquired what the selection criteria's were to select a firm. Mr. O'Brien answered the committee considered technical expertise, key personnel and their references, commitment of resources, and overall quality of their response.

Ms. Gere moved to award the Architectural and Engineering Services Agreement #17-013-F to TCF Architecture. Mr. Wesen seconded the motion. The motion passed unanimously.

## c) <u>Authorize the Registration of Skagit Transit for Cooperative Purchasing with the National Joint Powers Alliance (NJPA)</u>

Mr. O'Brien informed the Board as a small public agency purchasing limited quantities, Skagit Transit is able to leverage better pricing through cooperative purchasing groups. Skagit Transit is currently a member of several such groups and has experienced savings both in purchase price and Procurement staff time. Mr. O'Brien noted State law encourages participation in cooperatives to eliminate duplication of efforts and the need to conduct formal bidding processes, thereby saving taxpayer dollars (RCW 39.34.030).

Mr. O'Brien stated staff wishes to enter a "Cooperative Purchasing Enrollment Agreement" with the National Joint Powers Alliance (NJPA) as a Participating Member, or complete their on-line registration form. The NJPA is a public entity created by Minnesota Statute 123A.21 serving all participating governmental and municipal agencies and non-profits nationwide to reduce the cost of purchased goods by leveraging their combined purchasing power. Mr. O'Brien noted this is accomplished through competitively solicited contracts for quality products through lead public agencies who are members of NJPA, and who allow participating public agencies to purchase from these contracts. NJPA's procurement process meets the competitive solicitation requirements of WA State and Skagit Transit's Policy. Mr. O'Brien added the City of Anacortes, City of Seattle, City of Yakima, City of Richland, Port of Longview, Spokane County, and Community Transit also purchase through NJPA.

Mr. Wesen moved to authorize the Contracts Administrator to register Skagit Transit as a Participating Member with the NJPA through either their online form or signing a Cooperative Purchasing Enrollment Agreement #17-019. Mr. DeGloria seconded the motion. The motion passed unanimously.

## d) Approve Interlocal Agreement between Skagit Transit and Skagit County #17-018

Mr. Schaner reported Skagit Transit maintains an Interlocal Cooperative Agreement with Skagit County's Public Works Department to perform work at Skagit Transit facilities on an as-needed basis and as the County's schedule permits. Mr. Schaner noted the County's services have been used for utility lamp replacements, parking lot resurfacing, tree pruning, and cleaning catch basins.

Mr. Schaner noted the current Agreement County #C20120603, expires December 31, 2017. The agencies desire to enter a new Interlocal Agreement, effective January 1, 2018, which shall continue until December 21, 2023. Skagit Transit agrees to reimburse the County for actual expenses plus 9% of the total cost for overhead.

Ms. Gere moved to approve Interlocal Agreement #17-018 with Skagit County Public Works Department. Mr. Quam seconded the motion. The motion passed unanimously.

**SUBJECT:** Award Transit Route Planning Software

**Skagit Transit Contract #17-020 (WTA #2017-280)** 

#### **INFORMATION:**

Skagit Transit staff determined a need for a complete Software as a Service (SaaS) hosted solution to provide more timely service and capital improvement planning. It is often difficult and time consuming to ascertain when and where future growth will occur and how much growth is expected, including modifications to roadway networks and future demographic density and profile. Currently, staff utilizes consultants for special tasks and projects and uses a combination of tools to collect data which is then manually manipulated to create reports for stakeholders.

Skagit Transit's goal is to reduce consulting costs by increasing staff capabilities through a Strategic Plan, Title VI Analysis, and the assistance of transit planning software. In 2018, a Strategic Plan will be conducted to guide service improvements to local routes and re-design service to the rural parts of Skagit County over the next 5 years. The assistance of transit planning software will enable Skagit Transit to better understand the resource costs and demographics (riders) impacted by any proposed service changes.

The same challenges faced by the Whatcom Transportation Authority (WTA) lead to Contracting staff from both agencies combining efforts in a joint procurement for "Transit Route Planning Software". WTA, as the Lead Agency, published Request For Proposals (RFP) #2017-280 on 11/3/17. Three responsive proposals were evaluated by a Committee comprised of representatives from both Agencies. Out of 100 points possible, results are:

The web-based software solution from Remix was mutually selected for contract award. Each agency will execute a Maintenance and Support contract and End User License Agreement to automatically extend as long as the software is used.

#### **RECOMMENDATION:**

Authorize the Executive Director to execute the contracts with for "Transit Route Planning Software" with Remix Software, Inc. of San Francisco, CA.

#### **BUDGET IMPACT:**

The five year financial impact of this procurement is \$73,000 for implementation (\$2,000) and five years of licensing (14,200/year). Licensing will be paid annually. Costs include all maintenance, upgrades, support, communication between host site and the Agencies, and any other ancillary costs for use associated with the software. Initial training and unlimited additional training are included at no extra cost. After Year 5, any economic rate adjustment to the license fee will not be more than 15% above or below the original contracted amount.

#### **INFORMATION:**

As a small public agency purchasing limited quantities, Skagit Transit is able to leverage better pricing through cooperative purchasing groups. Both awards are for the purchase of replacement vans for the Vanpool Program. Skagit Transit will blend funding sources to the maximum extent possible of the state and federal grants to meet the replacement vehicle needs, any remaining balance will be satisfied with local funds.

Skagit Transit maintains a Master Contracts Usage Agreement (MCUA) with the State Department of Enterprise Services (DES) in order to utilize their competitively let contracts for various items and services, in accordance to State and federal procurement regulations. This is the preferred method for public agencies procuring property and services as it alleviates the redundancy and cost of the public body conducting its own competitive process for the same items or services, and the State can offer more economical pricing through its multiple awards and expanded purchasing power.

State Contract #05916 is available for the purchase of 12 and 15-Passenger vans from two Contractors: Bud Clary Dodge, Longview, WA offers the Chrysler Pacifica van; and Columbia Ford, Longview, WA offers the 12-Passenger Ford Transit T35 van.

## **INFORMATION:**

Skagit Transit's existing Bus Shelters Contract #12-007-F with Duo-Gard Industries, Inc. expired November 30, 2017. The next planned purchase for bus shelters is in the 2018 Budget therefore it is necessary to rebid for a new contract. Skagit Transit intends to purchase up to a maximum quantity of 22 bus shelters over a five-year term for a total estimated cost of \$105,000. The scope of the new contract includes a 3' x 10' Cantilever type bus shelter, in addition to our standard 5'x 10' Full-Size shelter, plus options for replacement items (window panels, roof, seals, benches, display cases, trash cans) and solar lighting. The contract is federally compliant in the event FTA funds are secured for purchasing bus shelters during the five-year Contract Term.

Invitation For Bids (IFB) #17-021-F was issued and posted on Skagit Transit's website on 11/15/17. Bid notices were posted at Skagit Station, the MOA, on Skagit Transit's website, and sent to 18 potential Bidders. The legal advertisement was published in the Skagit Valley Herald on 11/16/17. One Addendum was issued to approve an equal trash receptacle to the one specified in the IFB. Sealed bids were received until exactly 10:00 a.m. on 12/1/17 and immediately opened in public meeting at the MOA. Two bids were determined responsive and both Bidders deemed responsible. Bids were evaluated on the Total Bid Price for 22 shelters:
