RE: SHB 1418 and Skagit Transit Board Representation

Dear Skagit Transit Board;

Joe A. Kunzler here, concerned rider of Skagit Transit and 2nd generation resident of Skagit County. I am writing you mostly asking that you please place on your November Board agenda how you intend to address <u>SHB 1418</u> implementation. SHB 1418 allows transit boards like Skagit Transit to have two voting members who are regular, enthusiastic transit users – and considering Skagit Transit's grant dependency, I submit please having these seats filled by active transit users can only help in improving Skagit Transit.

Granted and honestly, I fully intend to apply for one of these positions. But I do want to point out some things:

- a) The legislation states, "Transit-using voting members may not be employees of the transit agency operating under the public transportation benefit area authority". Please seek clarification if Community Advisory Committee members fall under this.
- b) As a former Community Advisory Committee member, I feel I was unable to have the CAC give input in that framework in certain circumstances, such as service planning decisions. There was one decision made several years ago where a proposed route was withdrawn and we did not know until I inquired what the plan was. Considering that Skagit Transit is entering a financially difficult time and the recent long-range plan's suggested routes were rejected by the community, these times require active *rider* input.

c) I would hope that you have applicants to this position share their plan to connect both Skagit Transit and the Board to the community Skagit Transit serves. My plan includes planning a monthly meetup in a different community, plus online outreach.

I would also add that Senator Liz Lovelett (40th LD) spoke on the State Senate floor for this legislation. Senator Lovelett shared,

"Having representation on local boards [from people] that have lived experience are crucial in providing these resources and services to the community. A couple of years ago, I participated in Disability Rights Washington 'Week Without A Car'. Now, unfortunately, in my area, that was exceedingly difficult, considering I have kids to get here and there, and kind of the limited nature of transportation services in rural areas, which speaks volumes in and of itself."

I believe the Skagit Transit Board should include those perspectives at the decision-making table. It is worth noting that there will be no Community Advisory Committee report on the agenda this month. I ask that you please amend your agenda to accommodate, please.

SUBJECT: Approve Interlocal Agreement to Donate Paratransit Vehicle

INFORMATION:

Skagit Transit recently received a request from Skagit County government requesting to receive the donation of an ADA-accessible paratransit vehicle (the "Vehicle") for use by a local non-profit organization, which provides assistance to eligible community members experiencing food insecurity, housing insecurity, or homelessness within Skagit County.

Under Skagit Transit's Fixed Asset Disposal Policy (Admin.085.010), the agency is allowed to do this under Exception A.

a) "When the sale or other transfer is to another municipal corporation or government agency;"

Staff would like to donate vehicle 759, a 2015 Chevrolet Startrans Senator, to Skagit County government to help them meet the needs of community members in Skagit County. This vehicle was slated to be decommissioned and sold at auction. Once this vehicle is transferred, Skagit Transit will have no further obligation to this vehicle. All future operating, maintenance, and insurance costs will be covered by the Skagit County government.

RECOMMENDATION:

Staff recommend transferring vehicle 759 to Skagit County government.

BUDGET IMPACT:

Vehicle's value is estimated at approximately \$8,500, however, auction prices vary based on market conditions.

INTERLOCAL AGREEMENT BETWEEN SKAGIT COUNTY AND SKAGIT TRANSIT FOR DISPOSITION OF SURPLUS PROPERTY

This INTERLOCAL AGREEMENT BETWEEN SKAGIT COUNTY AND SKAGIT TRANSIT FOR DISPOSITION OF SURPLUSE PROPERTY ("Agreement") is entered into this ____ day of _____, 20, by and between Skagit County, a municipal corporation of the State of Washington ("County"), and Skagit Transit, a municipal corporation operating within Skagit County ("Skagit Transit"). The County and Skagit Transit may be referred to in this Agreement individually as a "Party" or collectively as the "Parties."

RECITALS:

WHEREAS, pursuant to Chapter 39.34 RCW, the Interlocal Cooperation Act, the Parties are authorized to enter into agreements to cooperatively exercise their powers for mutual benefit; and

WHEREAS, Skagit Transit owns vehicle 759, a 2015 Chevrolet Startrans Senator, an Americans with Disabilities Act (ADA) accessible paratransit vehicle that is at the end of its useful life for Skagit Transit; and

WHEREAS, Skagit County seeks to receive the donation of this ADA-accessible paratransit vehicle (the "Vehicle") for use by a local non-profit organization, which provides assistance to eligible community members experiencing food insecurity, housing insecurity, or homelessness within Skagit County; and

WHEREAS, Skagit Transit Policy #085.10 establishes the framework and guidelines for Skagit Transit to donate assets to "Qualified Organizations" for public benefit; and

WHEREAS, "state agencies" and "tax supported agencies" within the State of Washington are included as Qualified Organizations under Skagit Transit Policy #085.10; and

WHEREAS, Skagit County, a state and tax-supported agency, is a Qualified Organization under Skagit Transit Policy #085.10 and is therefore eligible to receive and distribute donated assets from Skagit Transit, including vehicles, for public benefit; and

WHEREAS, the Parties find that Skagit Transit's donation of this ADA-accessible paratransit vehicle to Skagit County will serve a public purpose by enhancing transportation resources to assist local individuals experiencing food insecurity, housing insecurity, or homelessness, all of which are of mutual concern to the Parties.

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein and for other good and valuable consideration, the Parties agree as follows:

1. PURPOSE

The purpose of this Agreement is to allow Skagit Transit the ability to donate surplus property to Skagit County in compliance with its asset distribution policy to achieve a goal that is mutually beneficial to the Parties and the community.

2. TERM AND TERMINATION

- (a) Term. This Agreement shall enter into full force and effect from _____ and shall remain in effect until the Vehicle is no longer in use for the purpose stated, herein, subject to earlier termination as provided in this Section 2.
- (b) <u>Termination for Breach</u>. This Agreement may only be terminated for a violation of the Agreement terms. In the event either Party breaches or fails to perform or observe any of the terms or conditions herein and fails to cure such breach or default within thirty (30) days' written notice thereof to the other Party, or, if not reasonably capable of being cured within such thirty (30) days, within such other period of time as the Parties agree may be reasonable in the circumstances, either Party may terminate this Agreement in addition to and not in limitation of any other remedy of the non-breaching Party at law or in equity, and the failure of the non-breaching Party to exercise such right at any time shall not waive that Party's right to terminate for any future breach or default. In the event of a breach, this Agreement shall remain in full force and effect until the conclusion of the Dispute Resolution pursuant to Section 10, herein.

3. MAILING ADDRESSES

Notices mailed shall be deemed given on the date mailed. The Parties shall notify each other in writing of any change of address.

4. SKAGIT TRANSIT'S OBLIGATIONS

- a. Skagit Transit agrees to donate the paratransit Vehicle to Skagit County at no cost. b. The Vehicle shall be transferred "as-is," with no warranties or guarantees, expressed or implied, regarding its condition or suitability for use.
- c. Title and ownership of the Vehicle shall be legally transferred to Skagit County upon execution of this Agreement and completion of any required title transfer documentation.

5. SKAGIT COUNTY'S OBLIGATIONS

- a. Skagit County shall designate the Vehicle for exclusive use by a local non-profit organization providing assistance to members of the community experiencing food insecurity, housing insecurity, or homelessness.
- b. The local non-profit organization must utilize the Vehicle to support transportation or housing needs, including but not limited to, transporting individuals to and from the food bank, housing services, and other essential service locations.
- c. The County shall ensure compliance with Skagit Transit's Policy #085.10 in the administration and oversight of the Vehicle's use.

- d. Skagit County shall assume all responsibility for maintenance, operation, and insurance of the Vehicle upon transfer.
- e. The County has the full discretion to donate the vehicle to a local non-profit organization providing assistance to community members experiencing food insecurity, housing insecurity, or homelessness within Skagit County pursuant to Policy #085.10.

6. HOLD HARMLESS AND INDEMIFICATION

- (a) Nothing contained in this Section or this Agreement shall be construed to create a right of indemnification in any third party.
- (b) Skagit County agrees to indemnify, defend, and hold harmless Skagit Transit, its officials, officers, agents, and employees to the fullest extent required by law, and further agrees to save, indemnify, defend, and hold Skagit Transit harmless from and against any and all claims, damages, liabilities, or expenses arising out of the County's use or disposition of the paratransit Vehicle.
- (c) Each Party agrees to be responsible and assume liability for its own wrongful and/or negligent acts or omissions or those of their officials, officers, agents, or employees to the fullest extent required by law, and further agrees to save, indemnify, defend, and hold the other Party harmless from any such liability. It is further provided that no liability shall attach to either Party by reason of entering into this Agreement except as expressly provided herein.
- (d) The terms of this Section shall survive the termination or expiration of this Agreement. No obligation shall exist to indemnify for injuries caused by or resulting from events occurring after termination of this Agreement.

FOR PURPOSES OF THE FOREGOING INDEMNIFICATION PROVISION ONLY, AND ONLY TO THE EXTENT OF CLAIMS BY THE PARTIES AGAINST EACH OTHER UNDER SUCH INDEMNIFICATION PROVISION, THE PARTIES SPECIFICALLY WAIVE ANY IMMUNITY THEY MAY BE GRANTED UNDER THE WASHINGTON STATE INDUSTRIAL INSURANCE ACT, TITLE 51 RCW. THE INDEMNIFICATION OBLIGATION UNDER THIS AGREEMENT SHALL NOT BE LIMITED IN ANY WAY BY ANY LIMITATION ON THE AMOUNT OR TYPE OF DAMAGES, COMPENSATION OR BENEFITS PAYABLE TO OR FOR ANY THIRD PARTY UNDER WORKERS' COMPENSATION ACTS, DISABILITY BENEFIT ACTS, OR OTHER EMPLOYEE BENEFIT ACTS.

7. INDEPENDENT CONTRACTOR

In providing services under this Agreement, the relationship of the Parties is that of an independent contractor. Neither Party, nor its officers, agents, or employees, are employees of the other Party for any purpose, including but not limited to, withholding of taxes, payment of benefits, workers compensation pursuant to Title 51 RCW, or any other rights or privileges accorded either Party by virtue of their employment. Neither shall the provision of services under this Agreement give rise to any claim of career service or civil service rights by the employee of one Party against another under any applicable law, rule or regulation. At all times pertinent hereto, employees of Skagit Transit are acting as Skagit Transit's employees, and employees of Skagit County are acting as Skagit County employees.

8. DISPUTE RESOLUTION AND VENUE

It is the Parties' intent to resolve any disputes related to the interpretation or application of this Agreement informally through discussions at staff level, or if necessary, through discussions between Skagit Transit and Skagit County. If a dispute arises from or relates to this Agreement or the breach thereof and if the dispute cannot be resolved through direct discussions, the Parties agree to endeavor first to settle the dispute in an amicable manner by mediation administered by a mediator under the American Arbitration Association's Rules before resorting to any filing in a court. The mediator may be selected by agreement of the Parties or through the American Arbitration Association. Following mediation, any unresolved controversy or claim arising from or relating to this Agreement or breach thereof shall be resolved by binding arbitration which shall be conducted under the American Arbitration Association's Arbitration Rules. The arbitrator may be selected by agreement of the Parties or through the American Arbitration Association. All fees and expenses for mediation or arbitration shall be borne by the Parties equally. However, each Party shall bear the expense of its own counsel, experts, witnesses, and preparation and presentation of evidence.

9. ACCESS TO RECORDS CLAUSE

The Parties hereby agree that authorized representatives of the Parties shall have access to any books, documents, paper and record of the other Party which are pertinent to this Agreement for the purposes of making audits, examinations, excerpts and transcriptions. All such records and all other records pertinent to this Agreement and work undertaken pursuant to this Agreement shall be retained by the Parties for a period of six (6) years after the final expiration date of this Agreement or any amendments hereto, unless a longer period is required to resolve audit findings or litigation. In such cases, the Parties may expressly agree by an amendment or separate agreement for such longer period for record retention.

10. GENERAL PROVISIONS

- (a) <u>Severability</u>. In the event any provisions of this Agreement shall be determined to be unenforceable or otherwise invalid for any reason. such provisions shall be enforced and valid to the extent permitted by law. All provisions of this Agreement are severable and the unenforceability or invalidity of a single provision herein shall not affect the remaining provisions.
- (b) <u>Governing Law and Venue</u>. This Agreement shall be governed by the laws of the State of Washington and venue for any lawsuit shall be in Skagit County Superior Court.
- (c) <u>Attorney's Fees</u>. In the event of litigation regarding any terms of this Agreement, the substantially prevailing Party shall be entitled, in addition to any other relief that may be awarded, to such reasonable attorney's fees and costs as determined by the Court.
- (d) <u>Waiver of Breach</u>. The waiver by either Party of the breach of any provision of this Agreement by the other Party must be in writing and shall not operate nor be construed as a waiver of any subsequent breach by such other Party.
- (e) <u>Savings Clause</u>. Nothing in this Agreement shall be construed to require the commission of any act contrary to law, and wherever there is any conflict between any provisions of this Agreement and any statute, law, public regulation or ordinance, the latter shall prevail, but in such event, the provisions of this Agreement affected shall be curtailed and limited only to the extent necessary to bring it within legal requirements.
- (f) <u>Filing</u>. This Agreement shall be filed with the Skagit County Auditor's Office or, alternatively, listed by subject on each or either Party's web site or other electronically retrievable public source pursuant to RCW 39.34.040.
 - (g) <u>Insurance</u>. Each Party shall be responsible for maintaining its own insurance.
- (h) <u>Modifications</u>. This Agreement may be changed, modified, amended or waived only by written agreement executed by the Parties hereto. Waiver or breach of any term or condition of this Agreement shall not be considered a waiver of any prior or subsequent breach.
- (i) <u>Interpretation</u>. This Agreement has been submitted to the scrutiny of all Parties and their counsel, if desired, and it shall be given a fair and reasonable interpretation in accordance with its words, without consideration or weight given to its being drafted by any Party or its counsel. All words used in the singular shall include the plural; the present tense shall include the future tense; and the masculine gender shall include the feminine and neuter gender.

- (j) <u>Entire Agreement</u>. This Agreement represents the entire integrated Agreement between Skagit Transit and Skagit County and supersedes all prior negotiations, representations or agreements, either written or oral.
- (k) <u>Counterparts</u>. This Agreement may be executed in multiple counterparts and each shall be deemed an original, but all of which together constitute a single instrument.




YTD Ridership Comparison (Jan-Sep 2025 vs. 2024)



UPT	Unlinked Passenger Trip – A single, one-way passenger boarding.
PMT	Passenger Miles Traveled – Miles traveled during which passengers are on board.
VRM	Vehicle Revenue Mile – Miles traveled when a vehicle is in service and available to collect revenue.
VRH	Vehicle Revenue Hour — Hours traveled when a vehicle is in service and available to collect revenue.
СВ	Commuter Bus - A fixed route with limited stops that primarily connects outlying areas with a central city.
MB	Motor Bus - A local fixed route with numerous stops that serves a smaller, defined area.
Total Miles	All miles traveled for any purpose, including service miles, deadhead miles, training miles, and travel to and from the depot.
Total Hours	All hours a vehicle is operated for any purpose, including service hours, deadhead hours, training hours, and travel to and from the depot.

October/November, 2025

The 2026 newly-elected slate of CAC officers are as follows: Chair Judy Jones, Vice-Chair Irene Prokuski, and Special Projects Assistant Ray Bock.

The announcements and staff reports were given.

The committee has been diligently turning in feedback, contributing to the upcoming rider guide changes, to include mapping and timetables suggestions.

In the coming months, the committee will be working on a buy-laws update, more to come.

The newly-launched statewide Nondriver Alliance is coming to Skagit County through November-December, and Director Anna Zivarts will be the speaker at our December 9 meeting. Meanwhile, appointments are being scheduled with board members and Skagit Transit officials. The state alliance is working to partner with transit agencies, ridership coalitions, and transit boards. Among other tasks and goals, Nondriver Alliance is educating everyone on Chapter 230 2025 RCW 36.57a.050, allowing PTBA boards to add two additional community ridership voting members. This law is effective January 1, 2026.

The alliance also serves as a training space for ridership to learn how various transit agencies are funded, and what boards will expect of any ridership members who serve. Transit boards in the state already having voting community members show positive relationships, affecting outreach and visibility.

MOVING OUR COMMUNITIES BEYOND CAR DEPENDENCY

The Nondriver Alliance is coming to Skagit County throughout November/December.

What is it? It is a newly-launched statewide organization, made up of people who cannot drive or afford to drive and who want to make transit and paratransit work better in our communities. We partner with transit agencies, community coalitions, transit board members, and any stakeholder in mass transit.

Purpose: To share mass transit information that builds community awareness and embraces participation on all levels. It also maintains that organizing and training transit riders to advocate for better public transit service and accessible, connected pedestrian infrastructure can provide a critical counter to the narrative that public services are not wanted or needed.

The weekly training component of the alliance serves as a space for ridership to learn about and understand mass transit funding, budgeting, and generally what transit boards require of their members under RCW 36.57A.050, Chapter 230, which takes effect January 1, 2026.

While advisory committees will still deal with the core issues and needs, as requested by their respective transit agency, the landscape of service to each agency is broadening, due to the grassroots ground-swell of statewide partnership and involvement.
